# ABOUT THE SEMINAR

Education plays a significant role in the growth and development of the individual and the Nation. Teachers being the implementing agents, have an important part to play in these aspects by imparting education to the masses. They have a vital role to play in not only achieving the desired goals and objectives of educational institutions but also in developing lifelong learning skills leading to the rise of learning communities and a welfare society. Highlighting the critical role of the teachers in holistic development of students and the Nation, the National Education Policy (NEP, 2020) states, "Teachers truly shape the future of our children - and, therefore, the future of our nation. It is because of this noblest role that the teacher in India was the most respected member of society". The policy places teachers at the center of the fundamental reforms in the education system for the next two decades. It expresses dissatisfaction, inter alia, with the existing quality of teachers, teacher education, and service condition. Taking cognizance of this, the, NEP, 2020 expresses a deep concern on the quality of teacher education programme, teacher deployment etc. and thereby empowering and support teacher's from all possible fronts. The motivation and empowerment of teachers are required to ensure the best possible future for our children and our nation. Therefore, the NEP (2020) envisages transformational reforms in teacher education in order to improve the integrity and credibility required to enhance the prestige of the teaching profession.

The policy aims to house teacher education programs outstanding education departments multidisciplinary autonomous colleges and universities and take stringent action against substandard standalone teacher education institutions. It also proposes to phase out teacher education institutions based on non-compliance with stated norms and standards, performance indicators, graded autonomy, and multidisciplinary, and to gradually move them into multidisciplinary colleges and universities. It envisions that only educationally sound. multidisciplinary, and integrated teacher education programs shall be in force by 2030. These lofty visions of the policy to overhaul the system of Teacher Education in the country is a huge challenge

before the government of India as well as state governments. With this backdrop of revamping teacher education; the North East Regional Institute of Education (NERIE), a constituent unit of NCERT, is organizing a National Seminar to deliberate on the issues and prospects of implementing various recommendations of NEP, 2020 to overhaul the system of Teacher Education at the Central and State level.
